



## **RECIPROCAL AGREEMENT**

**GLENELG GOLF CLUB** and **BRISBANE GOLF CLUB** have agreed to enter into an agreement whereby:

### **A. PLAYING RIGHTS**

1. Each of the undersigned Clubs shall extend to any visiting Member of the other Club facilities usually provided to its own Members in the category of membership which is closest to the rights and privileges to which visiting Member is entitled at their home Club.
2. Visiting playing rights will be extended only to visiting members who are playing members of the reciprocal club.
3. Visiting member shall have no playing rights on Wednesday or Saturdays, unless special approval is sought from the General Manager under special circumstances. (This may be reviewed at some point in the future)
4. Visiting Members shall abide by the booking procedure advised by the host club.
5. Visiting Members must upon arrival produce an introductory letter and identification. It is preferable that a letter of introduction is sent to the visiting club prior to arrival.
6. The host club's rules and regulations will apply to the visiting member during their visit to the host club.
7. A visiting member exercising visiting playing rights at a host club may do so on not more than four (4) occasions in any calendar year.
8. A visiting member exercising visiting playing rights will not be required to pay any green fee to the host club but may be liable to any fees usually payable by members of the host club eg. Mandatory Cart Hire or Competition Fee.
9. Subject to course availability and prior approval by the General Manager of the host club, a visiting member shall have the same rights to introduce guests as are applicable to a member of the host club. Such guests shall pay the current member-introduced visitor green fees.
10. Any purchases made by a visiting member at the host club must be settled, either by cash or credit card, on the day of the visit.



11. A visiting member is eligible to enter minor golf competitions conducted by the host club but may not enter major competitions or any perpetual trophy events at the host club.
12. Bookings from reciprocal clubs are restricted to a maximum of eight (8) players on any one day. Groups larger than eight (8) players will be treated as 'group booking' subject to approval by the General Manager and each player will be required to pay a green fee equivalent to the member introduced rate at the time.

#### **B. MEMBERSHIP TRANSFER**

1. Upon transfer of a member's residence interstate, the member shall have the right to make application for membership to the reciprocal Club. The application must be accompanied by a letter from the General Manager of the home club setting out the Club's approval of such application. Each club shall then consider such application on its merits and without obligation.
2. If at the time of application to the recipient Club, pursuant to this agreement, there is a vacancy in the relevant category, the applicant shall receive priority over other applicants for membership to that category. Pending admission to membership the recipient Club shall grant playing rights on such conditions and subject to such fee as the Committee of the recipient Club shall determine. A person elected to membership by a reciprocal Club under the terms of this agreement must pay, in addition to the pro rata subscription, the differential of the entrance fee applicable to that Club.

#### **C. TERMINATION OF AGREEMENT**

1. This agreement shall remain in force until such time as either Club upon written notice terminates it.
